1. CEO Report

- Financials covered in the Finance Committee meeting immediately after.
- MOU discussion at October 5th Mayor and Council Meeting. It was discussed
 that most of the requested changes were minor and would not need to return to
 the full board for approval. It was also noted that Mayor & Council did not get
 beyond comments on the document, and that Ms. Rivarde should speak with the
 City Manager about scheduling another work session between the Board and the
 Mayor & Council to discuss economic development goals.
- Incentive Fund Review At the Mayor & Council meeting on October 5th, it was indicated that one councilmember may want to have the Council re-consider the incentive fund requirements, particularly those for the Small Business Impact Fund. However, it did not appear that the full Council moved that item forward for discussion. Therefore, Ms. Rivarde and Ms. Prince will reach out to discuss the incentive programs with Councilmember Feinberg.
- Hiring Deputy/Director of Economic Development. A full quorum was not present to discuss in detail.
- MWBC will hold its 10th Anniversary Celebration on November 19th, which will include a graduation ceremony for Shop Local tenants.
- MWBC and REDI are sponsoring the Entrepreneur Award for the Rockville Chamber Rockstar Awards, which will be held on December 3rd.
- MWBC is continuing to have topical monthly blogs. Ms. Prince requested that the REDI website launch prior to the next Board of Directors meeting, and Ms. Rivarde agreed to work with GKA to make that happen.
