Focus of March 10 Roundtable

- Return to work
 - ✓ What are people thinking about?
 - ✓ Will they even return to work?
 - ✓ What are the legal implications?
 - ✓ Vaccines:
 - Are they safe?
 - What do employers/employees need to know?
 - How can employers present this to employees trying to decide if they should take the vaccine or not?
 - Attorney input:
 - Can you enforce the vaccine?
 - What if a person is allergic? ADA? Religious reasons?
 - What are the reasonable accommodations that an employer would be required to make to accommodate an employee?
 - What about the people who have already been out there working during the pandemic without vaccine access? Are they required to get one now?
 - Inviting an infectious disease expert to the panel might be a good idea.
 - ✓ How do companies decide if they go fully or partially remote?
 - Feedback from other companies would be helpful. What is the criteria for their decisionmaking?
 - What are the implications from surrounding businesses that have relied on these companies being in their physical locations (i.e., restaurants, grocery stores, childcare centers, hotels, etc.)?
 - What is the domino effect? What businesses will be able to re-open and thrive because companies have gone back to the workplace?
 - ✓ Reach out to Arlean Pietranton at the American Society of Association Executives (ASAE) as a panelist. (Fizie Haleem will contact her.)
 - ✓ Follow policy and policymakers to give insight on recovery (i.e., Senator Ben Cardin, Rep. Chris Van Hollen).
