### **ExportMD Grant**

- Reimburse 2/3 of up to \$7,500 expenses (a total reimbursed value of up to \$5,000)
- Eligible expenses:
  - Fees for shipping sample products
  - Cost of compliance testing an existing product for export market
  - Export research tool subscription for market research
  - Website development (design, with international focus; translation into foreign language; search engine optimization; localization services; international payment set-up)
  - Design of marketing media
  - Ecommerce platform hosting/maintenance fees
  - Online market listing fees
  - Registration costs for virtual trade shows and missions
  - Travel expenses
- Deadlines: First of every month before the month of use
- Validity: Six months upon receiving the award
- Managed through the ExportMD portal

#### **Trade Shows**

- Arab Health Jan 2024 Dubai
  - ArabHealth is one of the world's largest healthcare show and the largest in the Middle East. It annually features 4,000+ exhibitors from around the world, and in 2023 the show attracted 122,000 professionals from 142 countries.
- Singapore Air Show Feb 2024 Singapore
  - The Singapore Airshow is Asia's largest aerospace and defense show. It brings together high-level government and military delegations, as well as senior corporate executives from around the world to forge partnerships and seal deals in this region.
- IFAT Munich May 2024 Munich, Germany (ExportMD by April 1, 2024)
  - IFAT Munich is the largest trade show for water, sewage, waste and raw materials management. It attracts 119,000 visitors from 155 countries' government, private industry and academia. There are 3,000+ exhibitors from 60 countries. Currently recruiting 6 companies.
- InfoSycurity Europe June 2024 London (ExportMD by May 1, 2024)
  - Infosecurity Europe is the largest cybersecurity event in Europe. It features 400+ exhibitors and 15,000+ visitors representing over 20 countries. Currently recruiting 6-8 companies.
- MEDICA November 2024 Düsseldorf (ExportMD by October 1, 2024)
  - MEDICA is the world's leading medical trade fair and the leading international event for the medical technology supply sector. Currently recruiting 10 companies.
- China International Import Expo November 2024 Shanghai (ExportMD by October 1, 2024)
  - CIIE is a trade show dedicated to imports into China, attracting close to half a million visitors each year with ~3,000 exhibitors and US\$75 billion worth of deals in 2022. Currently recruiting life science and cleantech companies
